Transcription of Interview with Henry Wrens October 5, 1995

My function was to implement decisions that had already been made uh... and of course I had. I had been a principle in Arlington county Wake Field High School which had almost as many students in that school as we had in the school as we had in the school system here. It wasn't a big transition for me in terms of size it was a major transition in terms of community attitudes. Um... because ahh... There was a lot of hesitating as what to expect. I won't say there was apprehension because there had been a limited amount of integration in the several years prior. Their had been some white teachers who had gone into predominately Black Schools and vice versa with the Black staff coming into the white schools. Ah... Not a great deal of uhh. Ahh. student mixing, but in the decision among the decisions that were made a that were made a couple of things have worked very much to the advantage of the school system. we had only five plants...3 of them were designated as primary schools and they had basically . Ahh....communities to serve that were ... We weren't evolved in a great deal of busing. Because with only three primary schools in the city and county each had a rather substantial uhh....attendance area....They were all kept at basically the same size. There was some uhh... Bussing. Some students who reasonable should have gone to Matthew Waley. Because it would be closer to some students that live in the grove community they were bussed to Wallsburg and that was before 199 was in so they basically drove by 199 to get to

My enfaist when school opened that fall and was basically on that if we worked together we could basically do anything we wanted to do. And the focus had to be providing excellence in education for all people. Ahh...Things went well in the beginning. In the fall we had one serious incident...Ahh.. the from my point of view it was the result of extremely poor judgement by two White staff members.

Ahh... it was following a football game ahh.. the athletic director of the high school and the person who was responsible for counting the receipts they were in an office. A group of rather boisterous students they were predominately Black, but their was some white students involved too.. as best I can know..Ahh.. Came down the hallway and the Athletic Director to nones knowledge had a pistol and he drew the pistol.....Ahh.. This cased tremendous reaction in the community, but not what you might expect. Because you live in a area where school systems

all over the county are taking very strong measures about weapons in the schools, but I was actually in Chicago when it happened an the ahh ... My Wife choose not to tell me. But we had direct treats made against our children ahh My wife got phoned here at the house saying that little red head son of yours won't come home.. describing the kids to a T. It had become a pretty bitter situation. I took a very strong position with respect to the staff members involved as far as I was concerned. This behavior was totally unacceptable and inappropriate. Ahh it ended up with a meeting in the auditorium of Matthew Waley School where basically and I don't know any other way to describe them. Upper county red necks were there in force. Fortunately I had the full support of the school board but ahhh. They were out for my scalp there is no question about it. Because they were defending this guy's right to have this gun in school. and I at the meeting proposed a policy which to my knowledge is still on the Books, prohibiting any staff or school member to carry any know of weapon in the school system, which the board adapted. That didn't solve everything . Because there was still the question of disciplining the teacher. And this simmered in the community for a while it was divisive issue.. Ah... the Black community was very quite about it however. It was largely the vocal group was the white male portion of the county. I think the black community was quite primarily because they knew it was a difficult situation. I think they supported what the school board was doing but there was no point getting into a shouting match. It wasn't going to give any purpose for anyone.

Then we hadn't gotten much beyond that than we got into a controversy over qualification of teachers... ahh... on this one the Black Community ahh.. was ahh... very vocal,... Because anh.. There was a young women who was a graduated Bruton Heights who had received her degree from one of the colleges in the area. I don't know which Norfolk state or it wasn't Hampton. I'm sure at any rate it was ahh... predominately Black college in the community ahh.. She did not have a masters degree which and she was applying for a position as a visiting teacher ahh... she had a major in sociology. She had nor experience and did not meet certification requirements for the visiting teachers position ahh.. there was a very strong feeling in the Black community that she was qualified because she had the degree and I took the position which I would have taken with any applicant that the degree in itself does not certify you for a teaching

position.you have to meet certification requirements of the state for the position..... and for VT a visiting teacher required 3 years of teaching experience and advanced training experience ahh. In that one we ended up in a mass meeting in the Norge auditorium.....

So when we got into the planning stages and of course a very difficult part of in a lot of communities especially when you haven't built a school for a number of year is what are you going to name the school..... Well the first suggestion was the Williamsburg James City /County High School. and the kids just no body could except that. Ahh so we got evolved in community but the kids basically came up with Lafayette High School. But is what is interesting about that as I'm sure both of you probably think that the school is named for the Marque de Lafayette because of the revolutionary war and what not in this area. That impart is true but it is also named for James Lafayette who was a young black slave who spied on the British and reported back to Washington's staff.... and there was it was

a very plan that the school had be named for both these the individuals and when they designed the class ring for Lafayette if you look at it you have depicted clasped hands and this is supposed to depict the Black and White. This naming of the school did a great deal in this community to help bring people together, ahh. Since that time of course ahh. two of the elementary schools have been named for prominent Blacks in the community who have been in the school system.....

(Mention Ester Batchler and Matt Gi as great teachers who were part of integration process)

We were dealing with such..??.. that in 68 an Elementary school principle whom I will not name ahh... very much wanted to acquire a bath tub so she could wash the Black children when they come to school dirty that is the kind of attitude we were dealing with...ah...and it wasn't she did this was not mean spirited on her part ahh...by any means. Because she basically loved all children very much. she was very sincere, but something like that isn't s very inappropriate because it suggest ahh..that the Black parents weren't maintaining proper hygiene for their children which was not the case. You got little things like that coming up occasionally that uhh..you just had to deal with......
